Did you know that these charitable trusts exist to funds provide support to Wagyl Kaip Southern Noongar people?

WKSN Aboriginal Charitable Trust Fund

WKSN Charitable Trust exists to benefit members of the Wagyl Kaip and Southern Noongar agreement group. It is not run by our corporation, and you don't need to be a member of our corporation to apply.

The Charitable Trust has the following objectives:

- Relief of poverty;
- Relief of the needs arising from old age;
- Relief of sickness or distress;
- The advancement of education; and
- Other purposes beneficial to the community, including promotion and advancement of law and culture

Two kinds of payments may be made to individuals:

- Elder payment: a one off payment of \$500 for people aged 60+ years of age.
- Funeral payment: \$2,000 per member, which is paid directly to an approved funeral home of applicant's choice.

The Trust also gives payments of \$11,000pa to six community centres in the WKSN region, and there is a grant funding program to support services and activities on WKSN country to support WKSN people.

Last month the state government made its third payment into the Noongar Boodja Trust. This is the third of twelve annual payments of \$50 million into the Future Fund and \$10 million into the Operations Fund.

These payments to the Noongar people are guaranteed for twelve years as part of the South West Native Title Settlement.

Payments will increase each year to keep up with inflation. The first payment of \$60 million was made in 2021, just after the Settlement took effect. A second payment of \$63 million was made last year, and this year's payment was \$68 million.

So what do these payments mean for us?

The payments are just one part of the Settlement, along with land, housing and other resources. The payments are made into two different funds, which are designed to provide both short-term and long-term financial sustainability to the Noongar Nation.

The Operations Fund will be used to support the work of the seven Noongar corporations for the first twelve years. This work includes social and economic programs, land management and advocacy on behalf of our people and community.

The Noongar Future Fund will remain untouched for these twelve years, giving it time to grow large enough to give our Noongar Nation with economic independence and sustainability, so that our work can continue long into the future.

The entire Noongar Boodja Trust, which includes these two funds, is protected by an 'independent trustee' for the first twelve years. The Noongar people appointed Perpetual as this independent trustee.

The Noongar Advisory Company (NAC) was created to provide important cultural context and understanding to Perpetual when it makes decisions about the Trust, so that Noongar views are always central to every decision that gets made.

Over these twelve years, Perpetual will transfer more and more responsibility to the NAC, preparing them to become the 'dedicated trustee', with full responsibility for the Trust. The NAC will then become the sole trustee for Noongar Boodja Trust, so that when it's used to provide social, cultural and economic benefits to the Noongar people for generations to come, all decisions will be completely in Noongar control.

Noongar Land Estate

The Noongar Land Estate (NLE) is an integral part of the work and the benefits of the South West Native Title Settlement. It's held by the Noongar Boodja Trust to provide opportunities for sustainable economic, social and cultural outcomes to the Noongar community.

It will initially hold up to 300,000 hectares of reserve or leasehold land and up to 20,000 hectares of freehold land across all of Noongar boodja. Places that land has been offered for consideration include Katanning, Albany, Wellstead, Gnowangerup, Kojunup, Walpole, Denmark, Jerramungup and Bremmer Bay.

Our cultural advice committee is now working with the Noongar Boodja Trust to select land for the land estate, a complicated process that will happen over the next three years. We will be holding information days in the second half of this year to explain the selection process and get your views about selection and future use.

Marine Park: DBCA has been working extensively with community representatives and stakeholders to enable delivery of a draft management plan for the proposed South Coast Marine Park. We thank them for their work getting the project to this stage. After a period for public comment on the draft plan, the park will be established early in 2024. One of the marine park's priorities will be protecting Noongar cultural and heritage values. The new park will have a Noongar name and be jointly managed by WKSN and DBCA, and as part of the joint management there will be some ranger jobs for WKSN people.

Cooperative Management Agreements: WKSN will soon begin cooperative management of the Conservation Estate (national parks, state forests, nature reserves and marine parks) with DBCA. A cooperative management committee with DBCA and our corporation will hellp us work together to: protect Noongar heritage and cultural values; ensure ongoing access to hunt, fish and camp; develop economic opportunities; promote Noongar employment within DBCA and identify areas to formally jointly manage.

The Aboriginal Cultural Heritage Act 2021 will significantly change the way Noongar heritage sites and values are protected and managed in WA. The new laws will give Wagyl Kaip Southern Noongar people more say in what Aboriginal heritage is and how to protect it. Our corporation will develop business plans and feasibility studies to determine whether to become the Local Area Cultural Heritage Service (LACHS). If we do become the LACHS for the WKSN Agreement Area, then the vast majority of Aboriginal heritage work will be undertaken by or under the direction of the corporation.

There will be lots of new announcements about land over the coming months, so stay tuned!

The Wagyl Kaip Southern Noongar regional corporation is ready to start its next phase of work, which will include hiring staff, developing strategies for social and economic programs to benefit the community, inspecting and accepting WKSN land into the Noongar Land Estate, and advocating on behalf of WKSN people and community.

It's important to us that our work reflects the priorities and needs of WKSN people, and we want to listen and learn from you.
